1. Key points

For the third quarter of 2024, the volume of services rendered by the main activity of educational organizations of the Republic of Kazakhstan amounted to 1266485.6 million tenge, of which 85.9% from the budget, 11.6% - from funds received from the population, 2.5% - at the expense of enterprises.

The largest volume of services in the main type of activity was formed in the field of basic and general secondary education, their volume amounted to 692129.3 million tenge or 54.6% of the total volume of services, in the field of preschool education and training 212856.4 million tenge (16.8%), in the field of higher and postgraduate education – 122302.7 million tenge (9.6%).

The smallest volumes of services in the main type of activity were provided for services in the field of primary education in the amount of 16635.4 million tenge, organizations operating schools for training drivers of vehicles in the amount of 762.4 million tenge and organizations of post-secondary education in the amount of 3.4 million tenge.

According to the results of the third quarter of 2024, 78.6% of the volume of services rendered in the main type of activity was provided by state-owned organizations, 20.7% - by private property organizations and 0.7% - by foreign-owned organizations.

In the reporting period, the volume of services provided by the main type of activity provided by small enterprises amounted to 644563.4 million tenge (50.9%), by medium-sized enterprises – 454862.9 million tenge (35.9%), by large enterprises – 167059.2 million tenge (13.2%).

The volume of services rendered by educational organizations through internet amounted 12701.4 million tenge.

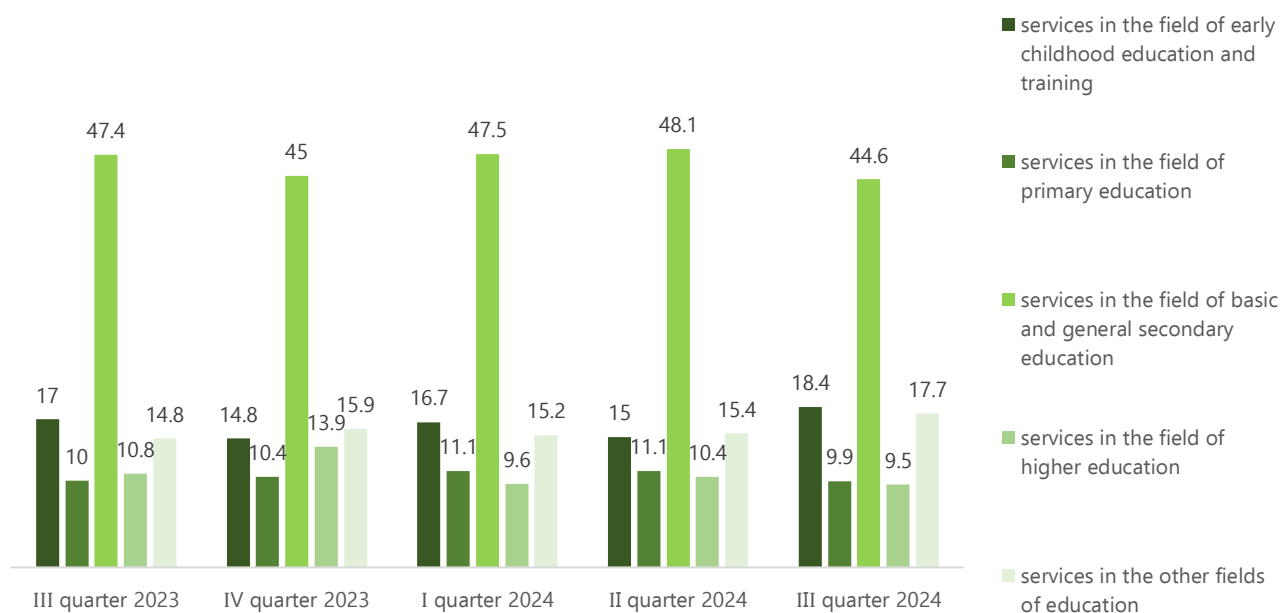

3. Glossary

The volume of services rendered - the cost of services rendered by educational organizations in the amount of funds that come from enterprises, organizations and (or) directly from the population (households) in payment for the services rendered to them and are estimated as the income of the organization, which, in turn, is estimated at the cost of sales received or receivable.

Services - activities aimed at meeting any needs of a person or society as a whole.

Main type of activity - a type of activity, the added value of which exceeds the added value of any other type of activity carried out by an economic entity.

Secondary type of activity is a type of activity, in addition to the main one, which is carried out with the aim of producing products (goods and services) for third parties.

4. Methodological explanations

The release presents statistical data of organizations with the main activity in the field of education of all forms of ownership, departmental affiliation and size of enterprises providing services in the field of education.

Services provided through Internet - services for providing educational and methodological materials, developing and maintaining the website of an educational organization, forms of interactive interaction between students with a teacher and with each other, as well as administering the educational process based on the use of the Internet at the levels of primary, basic and general secondary, technical and vocational, post-secondary, higher education.
