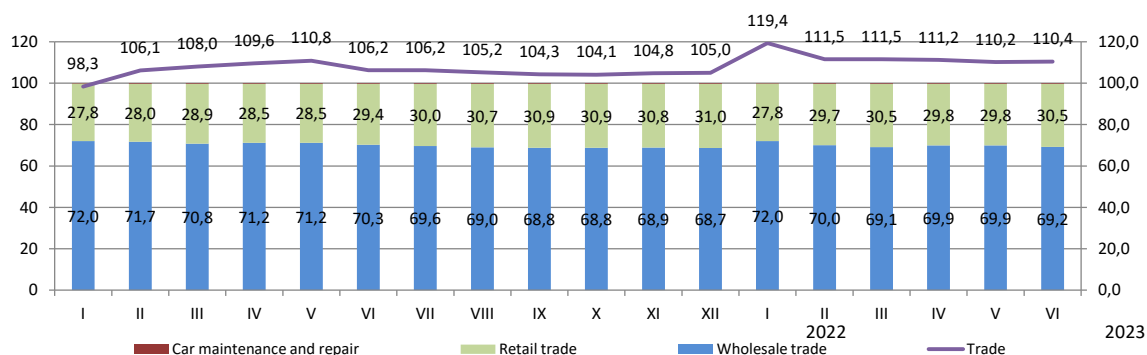

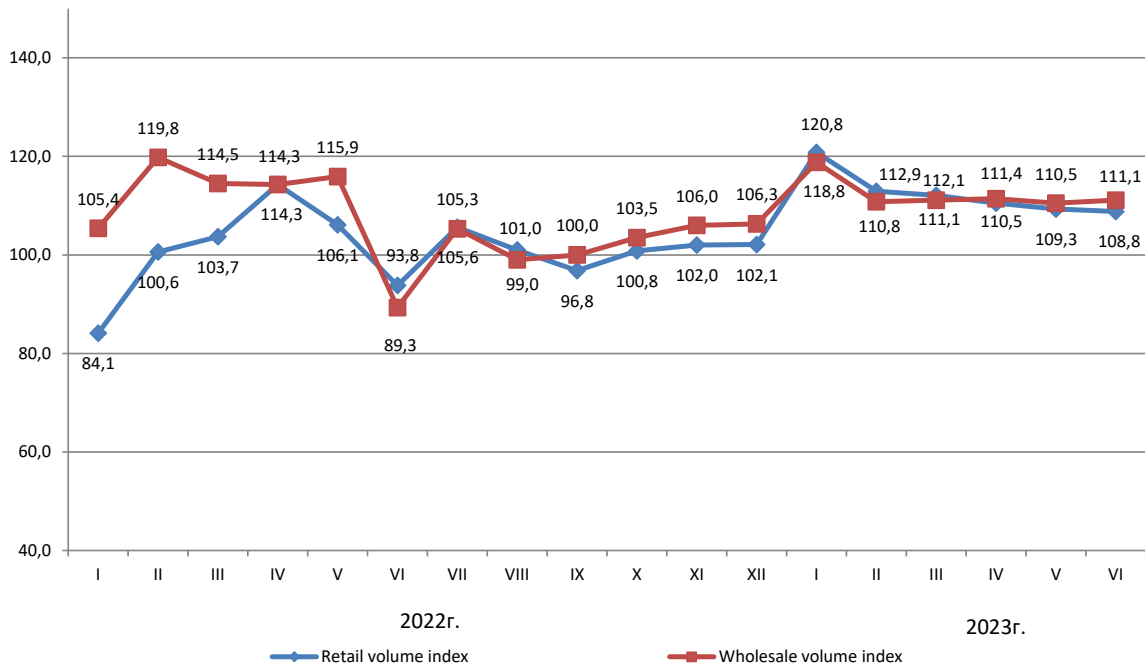
1. Key points

- IPV in the Trade sector in January-June 2023 compared to the corresponding period last year amounted to 110.4% (January-June 2022 – 106.2%).
- In January-June 2023, IPV of wholesale trade amounted to 111.1% (in January-June 2022 - 108.5%). IPV of the retail trade amounted to 108.8% (in January-June 2022 - 101.2%).
- A significant share in the total volume of the industry falls on wholesale trade, the share of which is 69.2%, the share of retail trade is 30.5%.

Picture 1. Physical volume index by industry Trade, in % to the corresponding period of the previous ye



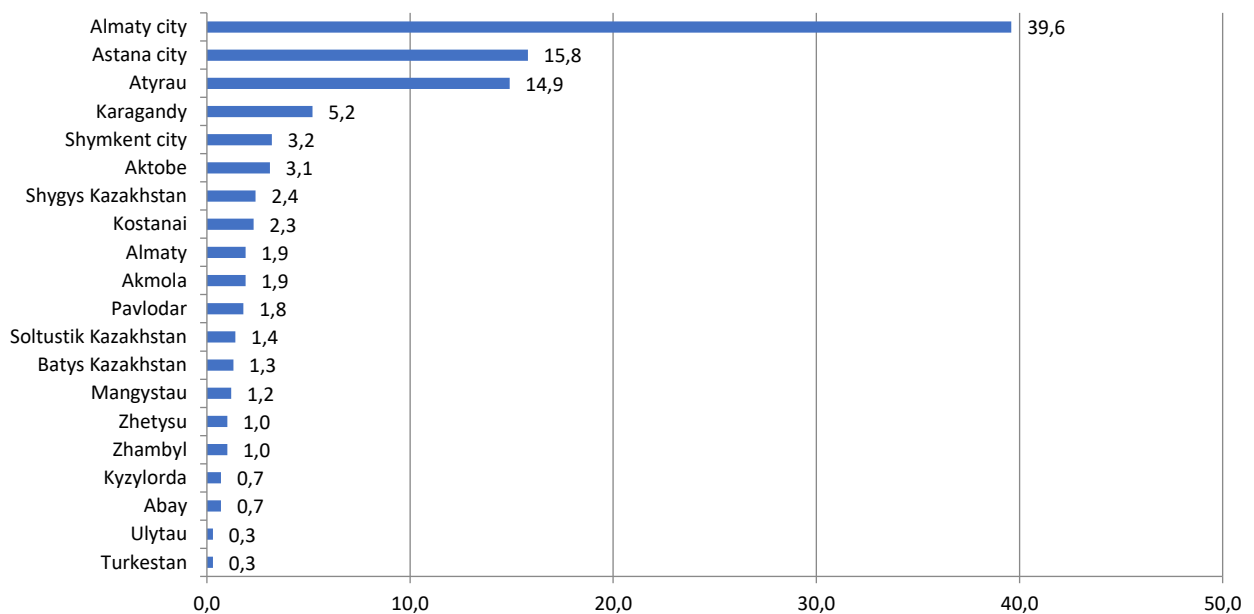
Picture 2. Index of physical volume of retail and wholesale trade, in % to the corresponding month of the previous year



The volume of wholesale trade in January-June 2023 amounted to 17612.4 billion tenge, or 111.1% compared to the corresponding period in 2022. Non-food products and industrial and technical products (82.6%) dominate in the structure of wholesale trade.

The largest share in the total wholesale trade of the republic in January-June 2023 falls on Almaty city (39.6%), Astana city (15.8%), Atyrau region (14.9%), Karaganda region (5.2%).

Share of regions in the total volume of wholesale trade, %



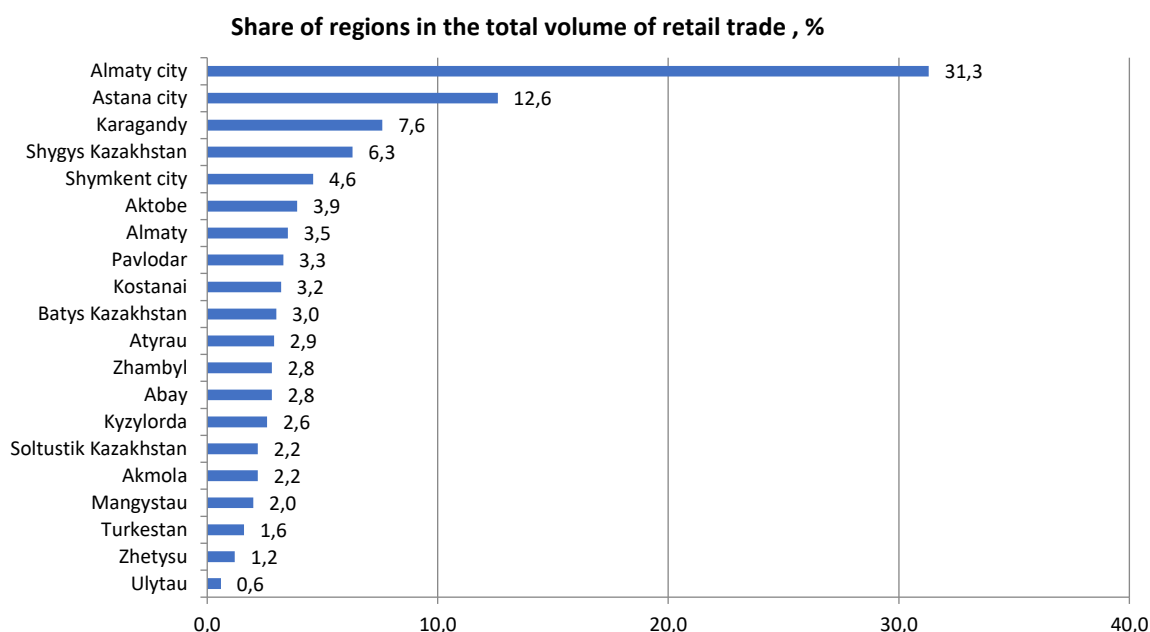
The volume of retail trade in January-June 2023 amounted to 7759.5 billion tenge, which is 8.8% more than the level of the corresponding period in 2022. Retail sales of goods by trading enterprises increased by 11.9%, by individual entrepreneurs, including those trading in markets, increased by 1.5% compared to January-June 2022.

From the beginning of the year, the turnover from the retail sale of goods by enterprises of private ownership received in the amount of 6901,1 billion tenge (88.9% of the total volume of retail trade), foreign ownership - 858.4 billion tenge (11.1%).

As of July 1, 2023, the volume of commodity stocks of trading enterprises (for reporting enterprises) in retail trade amounted to 1538 billion tenge, in trading days - 72 days.

The share of food products in the total volume of retail trade is 29.3%, non-food products - 70.7%. The volume of sales of food products compared with January-June 2022 decreased by 6.4%, non-food products increased by 16.8%.

The largest share in the total retail trade of the republic in January-June 2023 falls on Almaty city (31.3%), Astana city (12.6%), Karaganda city (7.6%) and Shygys Kazakhstan region (6.3%).



3. Glossary

Retail trade - resale (sale without processing) of new and used goods to the public for personal consumption, home use or disposal.

Wholesale trade - resale (sale without processing) of new and used goods to retailers, industrial, commercial, institutional or professional users or other wholesalers, as well as persons acting as agents or brokers when purchasing goods on behalf of such persons or companies or selling goods to them.

Index of the physical volume - a relative indicator that characterizes the change in the volume of sales of commodity mass (quantitative factor of commodity turnover) in the current period compared to the base one.

Commodity stocks - the amount of goods in cash or in kind, located in trading enterprises, in warehouses, in transit on a certain date.

4. Methodological explanations

The volume of sales of goods and services characterizes the amount of cash proceeds received for the sold goods, products and services rendered for cash and non-cash payments.

The index of the physical volume of turnover shows how the turnover changes as a result of changes only in its physical volume, excluding the influence of price changes.

To calculate the index of the physical volume of sales of goods (services), the turnovers of the reporting and base periods are compared in the prices of the same period taken as the base period (in constant prices).
