1. Key points

In January-April 2023, the volume of construction work increased by 15.4% and amounted to 1015.1 billion tenge.

Of the total volume of construction work in the republic, private construction organizations – 79.6%, foreign – 20.2% and state – 0.2% were performed.


2. Volume of completed construction works

The increase in the volume of construction work in January-April 2023 compared to January-April 2022 is associated with construction and repair of non-residential buildings (by 21%) and structures (by 20.6%).

By types of construction work (services) performed in January-April 2023, the largest share is occupied by construction of non-residential buildings (21.2%in the total volume) and residential buildings (13.2%).

In the regional context, an increase in the volume of construction work was observed in all regions of the republic. Significant growth was noted in the regions of Abay (by 59,8%), Zhambyl (by 47.3%), Kyzylorda (by 44%), Mangystau (by 39.4%), Batys Kazakhstan (by 34%), Zhetisu (by 21.4%), Soltustik Kazakhstan (by 19.2%), Atyrau (by 17.8%), Aktobe (by 15%) regions and in the city of Shymkent (by 23.7%).



In January-April 2023, the total area of new facilities put into operation amounted to 4 937.9 thousand square meters

The total area of housing commissioned increased by 19.9% compared to January-April 2022 and amounted to 4 329.4 thousand sq.m., of which 2 474.8 thousand sq.m. - multi-apartment and 1 823 thousand sq.m. - individual houses. Most of the housing - 4 150.4 thousand sq.m. or 95,9% was put into operation by private developers, of which the population is 1 843 thousand square meters.



In the field of education and healthcare, in January-April 2023, 9 general education schools for 2 974 student places, 10 preschool institutions for 516 places, 1 hospital for 150 beds and 1 clinic for 525 visits per shift were put into operation.

4. Glossary

Construction and installation work - construction work on the construction of buildings and structures, expansion, reconstruction and technical re-equipment; work on the installation of power, technological and other equipment.

Construction object - a separate building or structure with all related equipment, inventory, tools, galleries, flyovers, internal engineering networks and communications, for the construction (reconstruction, expansion) of which an independent object estimate is compiled.

5. Methodological explanations

Construction organizations include all general construction and specialized organizations, including repair and construction organizations. The main activity of construction organizations is to perform work under contracts with customers related to the type of economic activity "Construction" in accordance with the state "General Classifier of types of Economic Activities (GCTEA).

The volume of construction work includes the cost of construction work performed by enterprises engaged in construction activities under concluded construction contracts, which includes construction of new facilities, major and current repairs, reconstruction, modernization of residential and non-residential buildings, engineering structures.

The index of the physical volume of construction works (services) is determined by the ratio of the volumes of completed construction works of the analyzed period to the previous period in actual prices, taking into account the deflator (price index).

The total area of a residential building (residential building) is calculated as the sum of the total areas of all dwellings and the areas of all non-residential premises, as well as the areas of parts of a residential building that are common property.
