1. Social indicators

Population size and migration

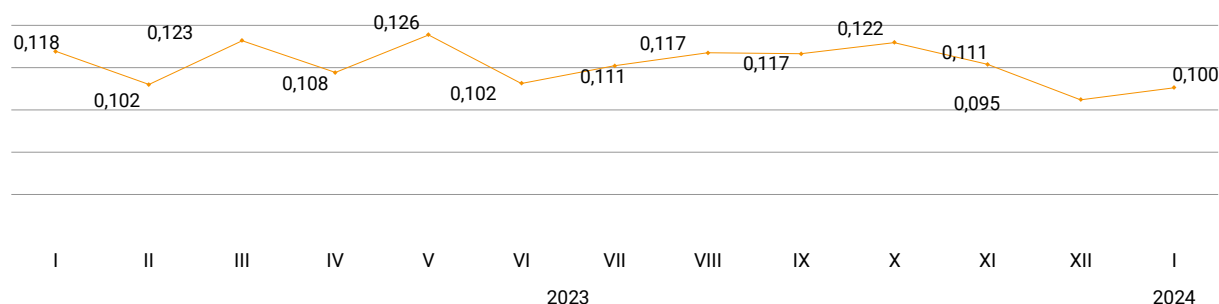
The population of the country as of February 1, 2024 amounted to 20053.7 thousand people, including urban – 12473.7 thousand (62.2%), rural – 7580 thousand (37.8%) people.

In January 2024, compared to January 2023, the number of arrivals in Kazakhstan decreased by 85.6%, the number of departures from Kazakhstan decreased by 39%.

The main migration exchange of the country takes place with the CIS countries. The share of arrivals from the CIS countries and departures to these countries amounted to 76.6% and 73%, respectively.

The number of migrants moving within the country increased by 99.3%. In terms of interregional movements, a positive net migration of population has developed in 3 regions of the country: the cities of Astana (5549 people), Almaty (4586 people) and Shymkent (2278 people).

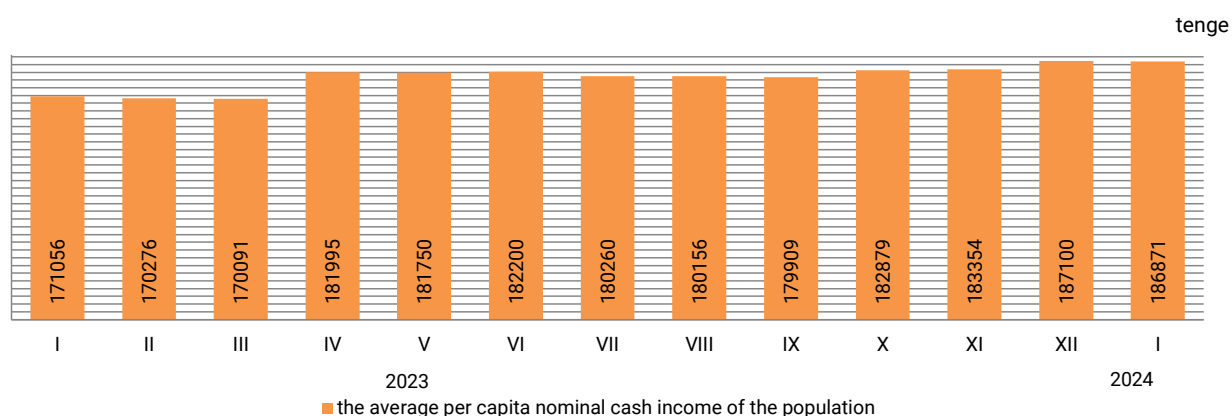

Income of the population

The average per capita nominal cash income of the population, according to an estimate in January 2024, amounted to 186871 tenge (preliminary data), which is 9.2% higher than in January 2023 real cash income for the specified period decreased by 0.3%.

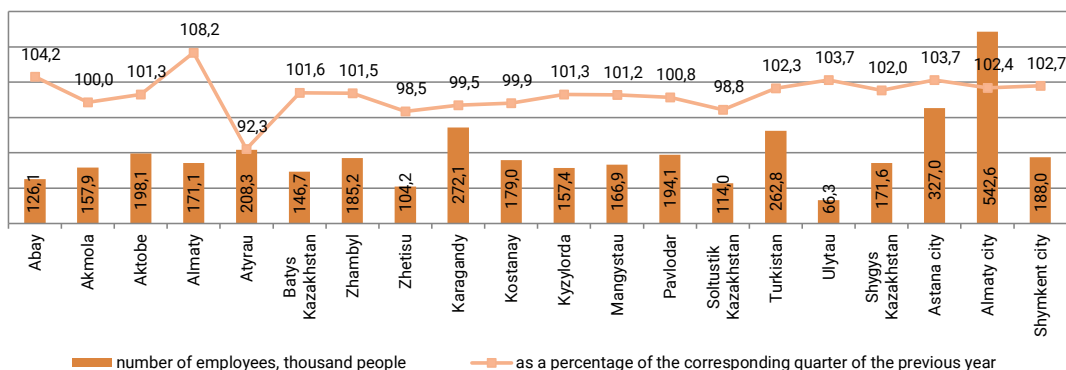
Employment of the population

The number of employees at enterprises (organizations) in the IV quarter of 2023³⁾ amounted to 3939,2 thousand people, of which at large and medium-sized enterprises – 2869,9 thousand people.

In the IV quarter of 2023, 247,2 thousand people were hired by enterprises. 241,2 thousand people dropped out for various reasons. Worked by one employee 473,1 hours.

At the end of the IV quarter of 2023, 54.2 thousand vacancies were not filled at enterprises (1.4% of the number of employees).

The number of unemployed, determined according to the methodology of the ILO, in the IV quarter¹⁾ of 2023 amounted to 445.9 thousand people, the unemployment rate was 4.7%.

The employed population²⁾ amounted to 9042.3 thousand people, including employees – 6906.3 thousand people, individual entrepreneurs – 1626.7 thousand people, persons engaged in private practice – 31.8 thousand people, individuals, who are founders (participants) of business partnerships and founders, shareholders (participants) of joint-stock companies, as well as members of production cooperatives – 16.2 thousand people, independent workers – 461.3 thousand people

From January 1, 2024, the minimum wage is set at 85000 tenge.

2. Economic indicators

Statistics of prices

The consumer price index in February 2024 compared to January 2024 was 101.1%. Prices for paid services increased by 1.7%, food products – by 0.8%, non-food products – by 0.7%.

Tarif increases were noted for hot water by 11.6%, central heating – by 10.7%, cold water – by 8.3%, sewerage – by 7.3%, garbage removal – by 0.9%. Air passenger transport services increased in price by 6.8%, cellular communication – by 6.2%, bathhouse services – by 3.8%, healthcare – by 2.1%, catering services – by 1.2%.

Among food products, prices for cucumbers increased by 14.8%, tomatoes – by 8%, sweet peppers – by 5.4%, bananas – by 3.8%, grapes – by 2.8%, carrots – by 2.4%, apples – by 2.1%, wheat bread made from first-grade flour – by 2%, drinking milk, potatoes – by 1.4% each, eggs, drinking water – 1.1% each, premium wheat flour – by 1%, rye-wheat bread – by 0.8%, black long tea, semi-smoked sausage, fish and seafood – by 0.7%. An increase in prices was noted for tobacco product by 1%. Buckwheat fell in price by 2.4%, sunflower oil – by 2%, granulated sugar – 1.5%.

Among non-food products, prices for household goods increased by 2.2%, cars – by 1.6%, personal goods – by 0.7%. Medicines increased in price by 1.2%.

In February 2024, compared with the previous month, the producer price index for agricultural products amounted to 100.3%, crop production – 100.4%, livestock products – 100.1%.

Prices for wheat increased by 0.9%, and for safflower seeds – decreased by 2.5%, dried lentils – by 1.6%, sunflower seeds – by 1.4%, dried peas – by 1.1%. Cucumbers of the closed ground rose in price by 12.9%, table carrot – by 2.2%, tomatoes of the closed ground – by 2%, table beet – by 1.4%.

Cattle rose in price by 1%, sheep – by 0.7%, and poultry meat – fell in price by 2.2%.

Prices for natural honey increased by 2%, chicken eggs – by 1.8%, raw milk – by 0.5%. Prices of manufacturing enterprises for industrial products in February 2024 increased by 0.4% compared to the previous month. Oil prices were higher by 0.7%, metal ores – lower by 0.6%. An increase in prices was noted for zinc by 1.3%, aluminum – by 1.1%, for lead – a decrease by 2.8%, copper – by 1.2%, rolled ferrous metals – by 0.9%. From food products, sugar rose by 5.1%, rye flour – by 3.7%, livestock meat – by 1.4%, dairy products – by 1.1%, cereals – fell by 3.7%, vegetable oil – by 2%, poultry meat – by 0.7%.

In the service sector, tariffs for the cargo transportation by all types of transport in February 2024 decreased as compared to the previous by 0.1%, increased postal and courier services – by 0.1%, tariffs for communication services remained unchanged.

In February 2024 compared to the previous month the prices index in construction for construction and installation work amounted 99.5%, for machinery and equipment – 100%, for other work and costs – 100.6%.

The calculation of the short-term economic indicator is carried out to ensure efficiency and is based on changes in output indices for basic sectors: agriculture, industry, construction, trade, transport and communications, accounting for over 60% of GDP.

Gross domestic product

In the structure of GDP for January-September 2023, a reported data, the production of goods amounted to 37.2%, the production of services - 54.2%. The main share in the production of GDP is occupied by industry - 27.7%, wholesale and retail trade; repair of cars and motorcycles - 15.8%.

According to the reporting data, in the sectoral structure of income formation for January-September 2023, compensation of employees in the production of goods and services amounted to 26,8% and 39,1%, respectively, the share of other taxes on production is 2 % in the production of goods and 1,9% in the production of services, respectively, the share of gross operating surplus/gross mixed income was 71,2 % and 59%.

The Gross Domestic Product calculated by the final expenditure method for January – September 2023 amounted to 74564047,0 million tenge. In comparison with the corresponding period of last year in real terms there is an increase in the component of final consumption expenditure: households – by 8,1%, government – by 7,7% and non-profit organizations serving households – by 5,2%.

Investment statistics

In January-February 2024, the volume of investments in fixed capital amounted to 1809,4 billion tenge, which is 7.9% more than in January-February 2023.

The predominant sources of investment financing remain the own funds of economic entities, the volume of which in January-February 2024 amounted to 1439,7 billion tenge.

In January-February 2024, compared with January-February 2023, there is an increase costs for the purchase of machinery, equipment and vehicles and their capital repairs by 35.9%.

A significant share of investments in fixed capital in January-February 2024 accounted for mining and quarrying (30.7%), operations with real estate (21.3%), transport and warehousing (13.3%) and manufacturing industry (11.5%).

The volume of investments of large enterprises in January-February 2024 amounted to 697.8 billion tenge.

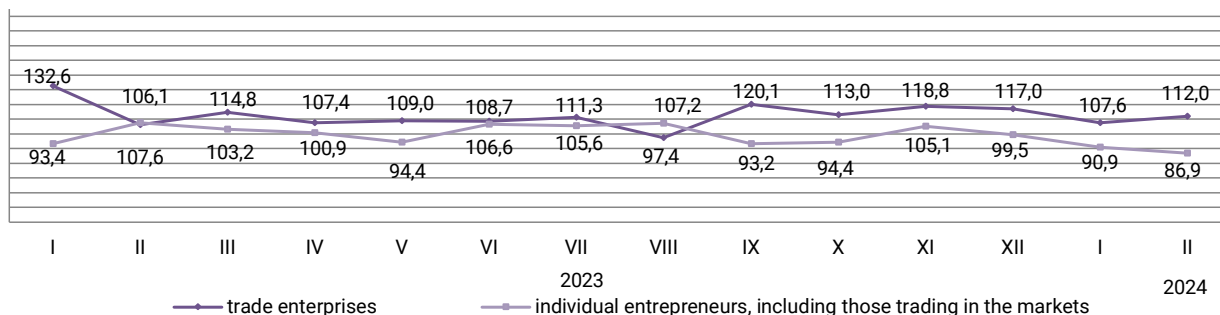
The volume of retail trade in January-February 2024 amounted to 2468.7 billion tenge, which is 4.7% more than the corresponding period in 2023. Retail sales of goods by trading enterprises increased by 9.9%, individual entrepreneurs, including those trading in the markets decreased by 11.2% compared to January-February 2023.

As of March 1, 2024, the volume of commodity stocks of trading enterprises (for reporting enterprises) in retail trade amounted to 1569 billion tenge, in trading days - 74 days.

The share of food products in the total volume of retail trade is 27.5%, non-food products – 72.5%. The volume of sales of food products compared to January-February 2023 increased by 3%, non-food products increased by 5.4%.

The volume of wholesale trade in January-February 2024 amounted to 5498.6 billion tenge, which is 4% more than the corresponding period in 2023. Non-food products and industrial and technical products (79%) prevail in the structure of wholesale trade.

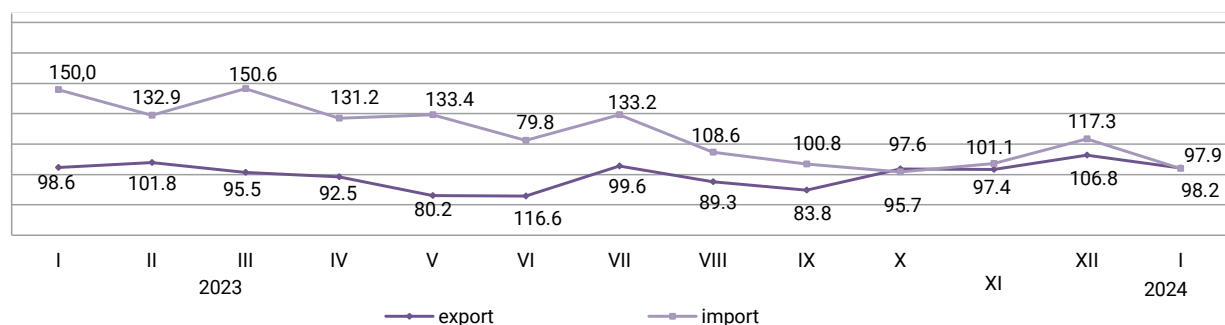

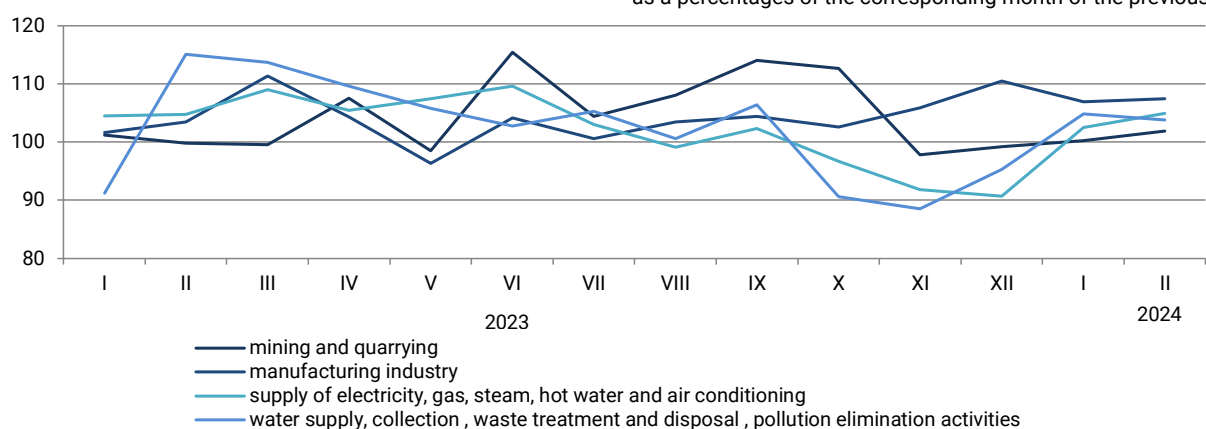

Statistics of building and housing construction

In January-February 2024, the volume of construction work increased by 12.7% and amounted to 356.6 billion tenge.

The largest amount of work in January-February 2024 was performed on the construction of non-residential buildings (164,3 billion tenge), facilities (143.2 billion tenge) and residential buildings (49,1 billion tenge).

The volume of construction and installation work in January-February 2024 compared to January-February 2023 increased by 15.6% and amounted to 327.8 billion tenge. The volume of construction work on major repairs decreased by 18.4% and on current repairs it increased by 4.7%.

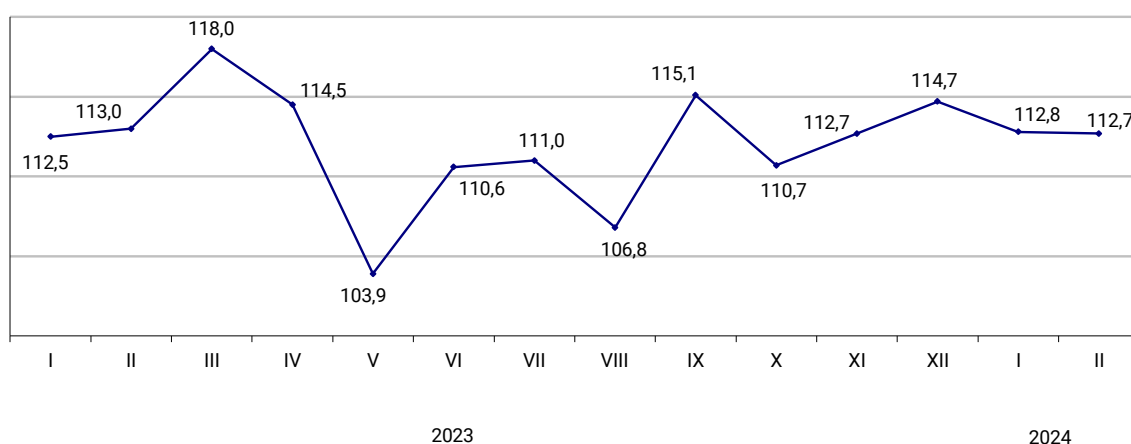
In January-February 2024, the construction of 4282 new buildings was completed, of which 3971 are residential and 311 are non-residential.

as a percentage of the corresponding month of the previous year



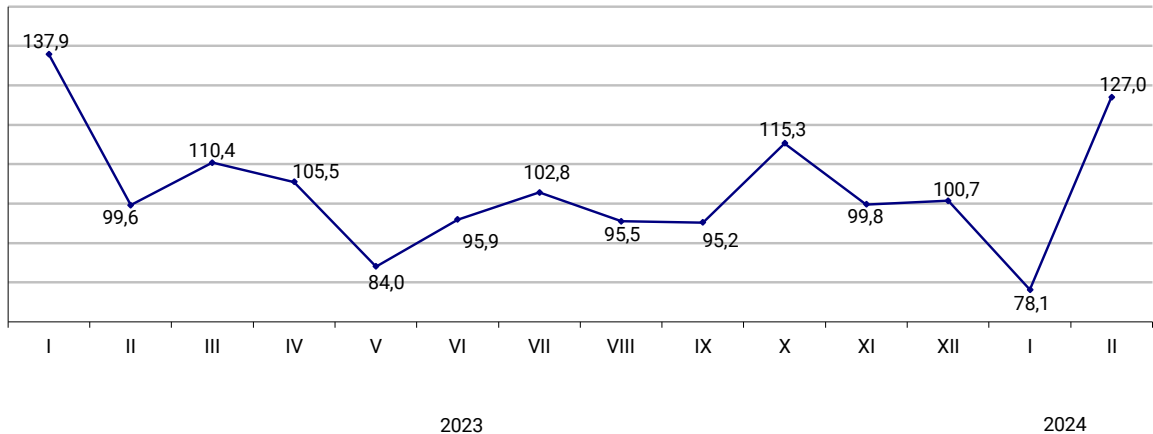

In January-February 2024, 369.1 billion tenge was allocated for housing construction. In the total volume of investments in fixed capital, the share of disbursed funds in housing construction amounted to 20.4%.

The main source of financing for housing construction in January-February 2024 is the own funds of developers, the share of which is 91.1%.

as a percentage of the corresponding month of the previous year

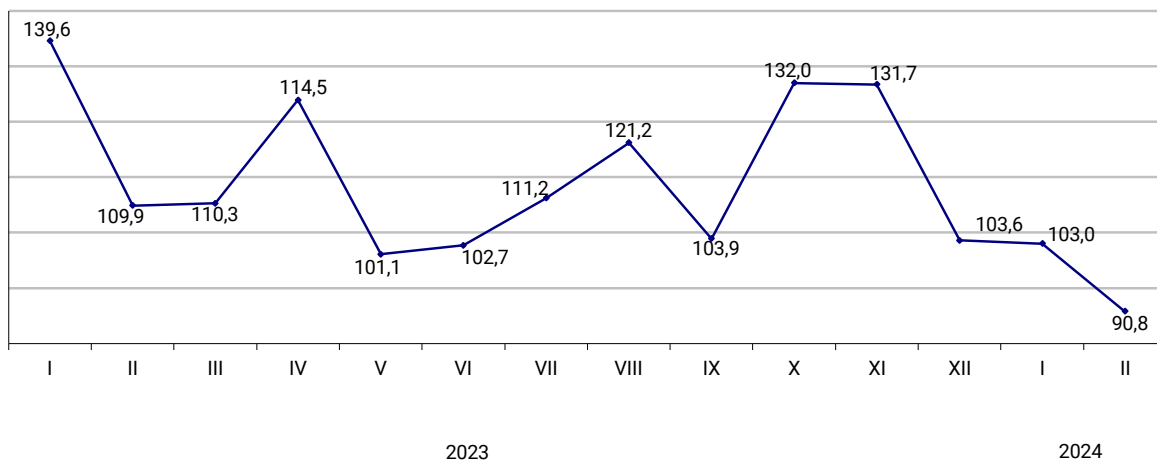


In January-February 2024, the total area of housing put into operation decreased by 3.4% and amounted to 2073.4 thousand square meters, of which in individual residential buildings - by 16.7% (699 thousand square meters). At the same time, the total area of multi-apartment buildings put into operation increased by 5.5% (1354.7 thousand square meters).

In the total volume of commissioned housing, the share of multi-apartment buildings was 65.3%, individual – 33.7%. The average actual cost of construction of 1 square meter of total housing area increased by 5.3%.

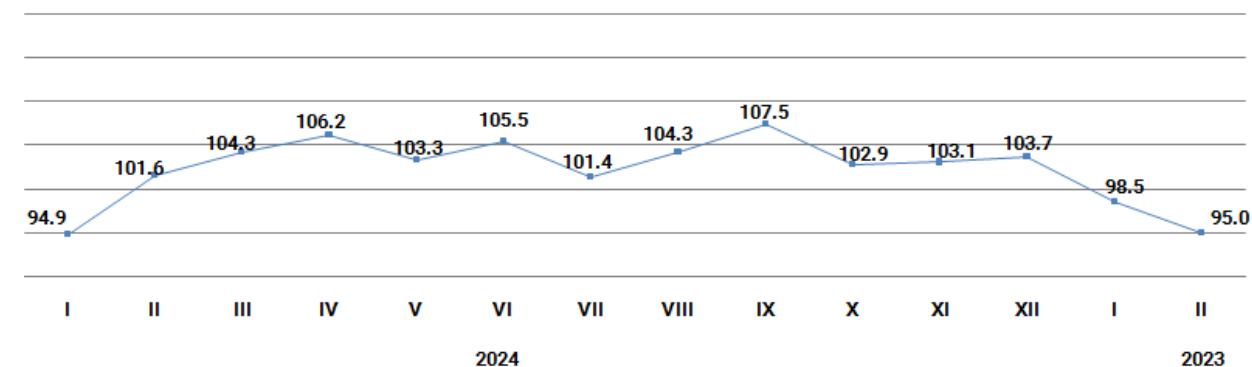

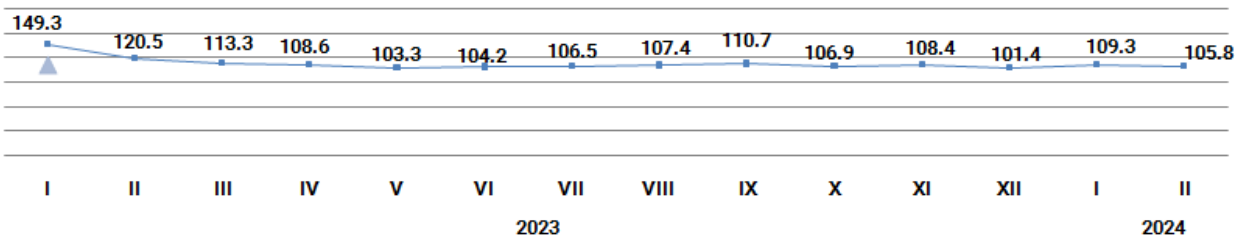

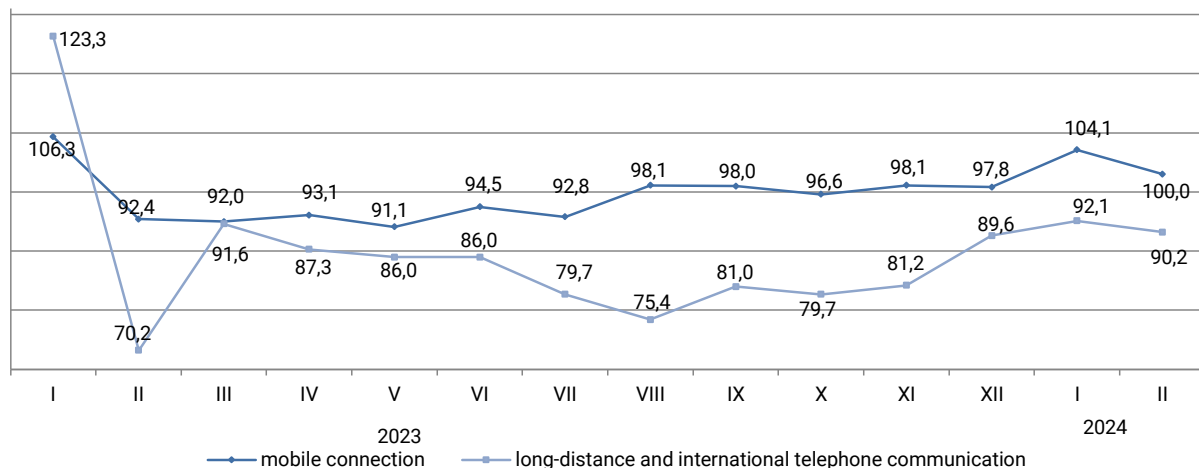
