S.2 Introduction-Relevance

This statistical observation in the form "Report on the main indicators of the financial and economic activities of the educational organization" (hereinafter - Social Finance (education)) refers to the education sector. The statistical form is compiled on the basis of data from the primary accounting documentation of educational organizations. The receipt and use of financial resources of educational institutions (organizations of preschool education and training, secondary schools, organizations of technical and vocational education, higher educational institutions) are calculated according to the accounting reporting method of educational organizations. The receipt of funds is characterized by the following indicators:

availability and sources of funding for these organizations (receipts from the state or

local budget), payment of parents for the maintenance of the child in the organization of preschool education and training, tuition fees for pupils (students), income from the rental of premises, equipment, etc.

The main indicators of the financial and economic activity of an educational organization are characterized by the following indicators: by items of income and expenses (current income, received transfers for capital expenditures, other income, current expenses, expenses for capital repairs, expenses for the acquisition of fixed assets), results of financial and economic activities organizations (income, expenses, profit (loss) before taxation, total profit (loss) for the period), indicators of the balance sheet (assets and liabilities)). The publications of the statistical report provide a breakdown by region, type of locality, forms of ownership and size of enterprises.

- 3) Expenses decreases in economic benefits during the reporting period in the form of outflows or decreases in assets or incurrence of liabilities that result in decreases in equity, other than those associated with distributions to equity holders.

The Department of Social and Demographic Statistics annually presents the indicators "Number of enterprises reported", "Number of unreported enterprises", "Number of enterprises with zero reporting" to estimate the volume of unreported enterprises.

In 2019, the number of respondents who reported was 21498, of which 19518 (90.8%) reported online. There is no duplication with other statistical observations. No administrative data or other sources are used.

The collection of data on the financial and economic activities of educational organizations is carried out in electronic form and on paper at the request of the respondent. Data collection is carried out online, in which automated arithmetic and logical controls are provided for the respondent, excluding the possibility of typical input errors. Information processing processes are automated using local software systems, control of input and output information is provided.

In the absence of activity during the reporting period, the respondent, no later than the end date of the earliest of the deadlines for submitting statistical forms for this reporting period, specified in the approved Schedule for submission by respondents of primary statistical data on national statistical observations for the corresponding year, shall submit a Notification of the absence of activity in the manner prescribed by the Submission Rules respondents of primary statistical data approved by the order of the Chairman of the Agency of the Republic of Kazakhstan on Statistics dated July 9, 2010 No. 173 (registered in the Register of State Registration of Normative Legal Acts No. 6459).
