S.2 Introduction - Relevance

Structural statistics is annual statistics, the purpose of which is to provide data on the financial and economic activities of enterprises in the non-financial sector of the economy (industry, construction, trade, transport, communications and services) in the context of regions and types of activity. The main tasks of structural statistics are to characterize the volume of entrepreneurial activity, the structure of the production system, to form an information base for calculating individual macroeconomic indicators, as well as to characterize the demography of enterprises and update the business register.

Currently, the basis of structural statistics is statistical observations of the financial and economic activities of enterprises using unified reporting forms that meet the international requirements of the SNA and national requirements. In particular, the indicators formed on the basis of statistical observation on the financial and economic activities of large and medium-sized enterprises are used:

- 1) in the calculation of intermediate consumption for the purposes of the System of National Accounts (SNA);
- 2) government agencies and businesses for economic settlements;
- 3) to monitor the target indicators of state programs;

4)to assess the contribution of large and medium-sized businesses to the country's economy.

Feedback from users is carried out through the blog of the Minister of National Economy of the Republic of Kazakhstan on the website of the Ministry of National Economy of the Republic of Kazakhstan www.economy.gov.kz. The Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan holds meetings of working groups (focus groups), with the participation of potential users and respondents, representatives of interested government agencies, as well as NPP "Atameken", which analyze in detail indicators of national statistical forms for their relevance and avoidance of duplication with indicators of departmental statistical forms and forms of administrative data.

S.4 Presentation of statistical information
S.4.1 Data description

Surveys of the financial and economic activities of enterprises are carried out throughout the territory of the republic, for all types of economic activities, with the exception of public administration, education and health care. Objects of observation are a set of legal entities in the non-financial sector created for the production of goods (services) on a commercial basis. The generated indicators allow us to assess the financial and economic activities of enterprises, the trend of their development, the study of regional characteristics, as well as to form indicators for the system of national accounts. Statistical form 1-PF contains the main indicators of the financial and economic activities of enterprises: income, expenses, volumes of products produced and provided services, financial results of enterprises, balance sheet indicators, volume of products manufactured, work performed and services rendered - the cost of all products manufactured, work performed and services rendered at manufacturer's prices; income from the sale of products and the provision of services - the amount of income received and receivable minus value added tax, excise taxes, as well as the cost of returned goods, sales discounts and price discounts presented to the buyer;

payroll number of employees - the number of persons hired under an employment contract, regardless of the term of its conclusion, except for persons performing work under contracts of a civil law nature, as well as hired part-time; wage fund of employees - the accrued total funds of the organization for remuneration of employees in cash and in kind (official salaries (tariff rates), additional payments, allowances, bonuses and other payments of a stimulating and compensatory nature), taking into account taxes and other deductions (income tax, compulsory pension contributions) regardless of the source of their funding and the term of actual payments; gross profit is understood as the difference between income from the sale of products and the provision of services and the cost of goods sold and services rendered; profit (loss) before tax is understood as the difference between the amount of gross profit, income from financing, other income and the amount of expenses for the sale of products and the provision of services, financing costs, administrative and other expenses;

Cash flow - the inflow and outflow of cash and cash equivalents for the period classified by operating, investing and financing activities; foreign exchange position - gross position on assets and liabilities denominated in foreign currency, recalculated in tenge using the final exchange rate at the reporting date.

S.4.2 Classification system

When conducting a continuous survey in form 1-PF "Report on the financial and economic activities of the enterprise", the following statistical classifiers are used:

- 1) KATO Classifier of administrative-territorial objects;
- 2) OKED General classifier of economic activities;
- 3) KFS Classifier of forms and types of ownership;
- 4) KRP Classifier of the dimension of legal entities;
- 5) KOPF Classifier of organizational and legal forms of management;
- 6) CSE Classifier of sectors of the economy;
- 7) SOF Directory of fixed assets.

The survey covers large and medium-sized enterprises in the non-financial sector of the economy (industry, construction, trade, transport, communications and services).

- 2) Data collection toolkit statistical form, national statistical observation "1-PF" Report on the financial and economic activities of the enterprise "(index 1-PF, frequency annual) and Instructions for filling out the statistical form of national statistical observation" Report on financial and economic activity of the enterprise "(index 1-PF, periodicity annual), approved by the order of the Chairman of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan dated February 4, 2020 No. 14.
- 3) The circle of respondents is legal entities engaged in entrepreneurial activities and branches of foreign legal entities with a payroll of more than 100 people. They do not represent the statistical form of the organization of education, healthcare, banks, insurance organizations, a unified accumulative pension fund, public funds, public associations.

Submission deadline is April 5 (inclusive) after the reporting period.

S.4.5 Statistical object

A legal entity (enterprise) with a payroll of more than 100 people.

S.4.6 General population (principle of selection of survey units)

The source for determining the general population is the Statistical Business Register, which includes information on legal entities registered in the Republic of Kazakhstan and their separate and structural divisions. The main criteria for the formation of the general population: Sign of activity (ACT) - 1 (active), 2 (temporarily suspended activity);

Dimension of enterprises (KRP) -215-225, 305-311 (payroll number of employees is more than 100 people);

General classifier of economic activity (OKED) - 01-63, 64.19.9, 64.30, 64.91-64.99, 66, 68, 69.2, 70-75, 77-82, 90-93, 95-96. With the exception of educational organizations, healthcare, banks, insurance organizations, a unified accumulative pension fund, public associations, public funds.

The methodological basis in structural statistics is IFRS, NFRS. Filling in financial statistical reports is carried out by the respondent on the basis of financial statements compiled using the Model Chart of Accounts and NFRS. Information on sections 7.8 of the financial and economic activities of enterprises is necessary for the National Bank in full for a comprehensive assessment of economic risks for financial stability, analysis of the vulnerability of the economy, assessment of macroeconomic factors that determine financial stability.

Annual information on Form 1-PF is used to calculate gross value added (GVA) in the system of national accounts.

The collection of the statistical form 1-PF "Report on the financial and economic activities of the enterprise" is carried out in electronic format and on paper at the request of the respondent.

Data collection is carried out online by means of an EDS, in which automated arithmetic and logical controls are provided for the respondent, excluding the possibility of typical input errors.

Information processing processes are automated using local software systems, control of input and output information, procedures for imputing missing data are provided.

There is no duplication with other examinations. No administrative data or other sources are used.
