Higher educational institutions are educational institutions that implement professional educational programs of higher and postgraduate education, aimed at training specialists with qualifications and (or) academic degrees "bachelor", as well as scientific and pedagogical personnel of higher qualifications. Data on the specialty "bachelor" is filled in in accordance with the "Classifier of areas of training with higher and postgraduate education", approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated October 13, 2018 No. 569. Registered with the Ministry of Justice of the Republic of Kazakhstan dated October 17, 2018 No. 17565.

S.4.1 Data description

The number of students in educational institutions includes the number of students in higher education institutions. In statistical reporting, data on the number of students are given by course, gender, age, specialty and other indicators. In the reports of higher educational institutions, in connection with the maintenance of a multi-level structure of education in the universities of Kazakhstan, indicators are included on the admission, contingent and graduation of specialists in areas of study (except for specialties), and by training levels - bachelor, specialist with higher education.
