- 4) undergraduate a person studying for a magistracy;
- 5) Master's degree postgraduate education, educational programs of which are aimed at training personnel with the award of a Master's degree in the relevant specialty;
- 6) residency a form of obtaining postgraduate advanced medical education in a clinical specialty;
- 7) residency student a specialist mastering educational curricula of postgraduate advanced medical education in clinical specialties;
- 8) Doctor of Philosophy (PhD) a degree awarded to persons who have mastered the doctoral program in the scientific and pedagogical direction and defended a thesis in the Republic of Kazakhstan or abroad, recognized in the manner prescribed by the legislation of the Republic of Kazakhstan.
