Population migration statistics provide essential information about a country's population. Obtaining timely information on the size and characteristics of the country's population is a prerequisite for planning socio-economic development and making informed decisions. Statistical data on population migration and their subsequent analysis and interpretation are important for setting targets and assessing the implementation of socio-economic plans, including monitoring the implementation of programs in the field of migration policy, as well as for measuring such important demographic indicators as the migration rate, intensity on arrival, intensity factor on departure

Statistical coupons are sent by the territorial divisions of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan to the relevant city and district statistics departments on a monthly basis no later than the 6th day of the month following the reporting month.

The act of acceptance and transfer of coupons for statistical accounting of arrival and departure is drawn up in two copies, one of which remains with the registering authorities, the second is sent to the territorial statistical offices.

S.4.4 Statistical concepts and definitions

Population migration - the movement of people (migrants) across the borders of certain regions with a change of residence. The number of persons who arrived and left is determined as a result of the processing of coupons for statistical registration of arrival and departure received from the migration police of the internal affairs bodies, which are compiled when registering the population at the place of residence.

The absolute and relative indicators of population migration, used to analyze the migration situation at the level of a country, region or settlement, characterize the general level of population mobility in the territory, the scale, structure, direction and effectiveness of migration flows over a particular period of time.

In the current statistical accounting, the numbers of arrivals and departures are conditionally fixed, but in reality we are talking about the numbers of arrivals and departures.

The main indicators of migration are:

number of arrivals (arrivals);

number of departures (departures);

migration gain (or decrease), migration balance, net migration.

Migration intensity indicators characterize the frequency of cases of change of place of residence in the population for a certain period. The most commonly used are the general annual rates of migration intensity per 1000 population.

The coefficients characterizing the intensity of migration reflect the differences in the migration mobility of the population or its various groups in a certain territory over a number of years and make it possible to compare the migration processes in individual territories and unequal periods of time. The coefficient of the effectiveness of population migration represents the ratio between the number of people leaving a particular territory for every thousand who arrived there. This indicator is expressed in the number of dropouts per 1000 arrivals.

Arriving, departing citizens of the Republic of Kazakhstan, foreigners and stateless persons for permanent residence apply for registration or deregistration at the regional, city departments of the migration service of the Ministry of Internal Affairs of the Republic of Kazakhstan. When registering or deregistering, employees of the migration service draw up statistical registration coupons designed specifically for statistics bodies. These statistical standards are submitted to the regional and city statistics departments on a monthly basis in a timely manner. Regional and city departments of statistics, in turn, check the correctness of filling in the statistical standards, in case of errors or incompleteness of information, they are returned for replenishment. Then statistical standards are transferred to the regional departments of statistics, where the data is encoded according to the reference data, entered into the electronic database, and checked for logical and arithmetic control. After that, the formed databases on migration of the population are transferred to the ITC of the Committee, where logical and arithmetic control is carried out at the republican level, editing, processing of data and the release of tables according to the plan of statistical work for the current year. Then the generated tables are transferred to the Bureau of national statistics, where the analysis, approval and dissemination of information is carried out.
