S.2 Introduction-Relevance

This statistical observation relates to the healthcare industry.

The statistical form is compiled on the basis of the data of the primary accounting documentation of the organizations of rehabilitation treatment and medical rehabilitation. In the information on these organizations, according to the List of sanatorium-resort organizations, the characteristics of the medical personnel, the bed capacity of the sanatorium-resort organization and information about the treated (rested) are indicated.

The main indicators of the sanatorium-resort activity of healthcare organizations are characterized by the following indicators: characteristics of medical personnel (the number of doctors of the sanatorium-resort organization at the end of the year, people; number of nursing staff at the end of the year, people; of which dentists), bed capacity of the sanatorium-resort organization (number of sanatorium beds, at the end of the year, units; including the number of sanatorium beds for children, units; spent bed-days, bed-day; of them by nonresidents), information on treated (rested) (number of treated (rested) for the year , people, total, of them women, non-residents, in a day hospital). The network of sanatorium and resort organizations, recreation and tourism organizations includes both organizations operating throughout the year and organizations of a seasonal nature. Organizations of all forms of ownership are subject to accounting.

The publications of the statistical report provide a breakdown by region, type of area, forms of ownership, signs of subordination and types of organizations according to the List of sanatorium-resort organizations.

The collection of data on health resort activities is carried out in electronic form and on paper at the request of the respondent. Data collection is carried out online, in which automated arithmetic and logical controls are provided for the respondent, excluding the possibility of typical input errors. Information processing processes are automated using local software systems, control of input and output information is provided. At the end of 2018, the number of respondents was 196 organizations, of which 67% report online. There is no duplication with other examinations. No administrative data or other sources are used.

The data set on health resort activities is based on sources of primary statistical information in the statistical form "Report on health resort activities". The statistical form is provided by the structural and separate divisions of the legal entity at the place of their location, if they have been delegated the authority to submit statistical forms by the legal entity. If structural and separate subdivisions do not have such powers, the statistical form is provided by a legal entity in the context of its structural and separate subdivisions, indicating their location. If the respondent has no activity during the reporting period, the respondent has the right, no later than the end of the reporting period, to provide, instead of the statistical form, a notification of the absence of activity, indicating the reasons for the absence of activity and the period during which this activity will not be carried out in accordance with Appendix 1 to the Rules for submitting primary statistical data approved by the order of the Chairman of the Agency of the Republic of Kazakhstan on Statistics dated July 9, 2010 No. 173, registered in the Register of State Registration of Normative Legal Acts under No. 6459.
