The purpose of calculating population indicators by ethnic groups is to obtain complete and reliable information on the population size by individual ethnic groups, which are necessary for conducting an effective social and economic policy, developing programs for the development of the country and regions.

Definitions:

The general increase (decrease) of the population is the algebraic sum of natural increase (decrease) and migration increase (decrease) of the population;

Migration increase (decrease) of the population - the difference between the number of arrivals for a certain period on the territory of the region and the number of those who left it;

Natural increase (decrease) of the population - the difference between the number of live births and the number of deaths over a certain period.

The methodology for calculating indicators of the size and structure of the population was developed taking into account the Recommendations of the Conference of European Statisticians on the 2010 Population and Housing Censuses, prepared in cooperation with the Statistical Office of the European Communities (Eurostat), the United Nations, New York and Geneva, 2006

Arriving, departing citizens of the Republic of Kazakhstan, foreigners and stateless persons for permanent residence apply for registration or deregistration at the regional, city departments of the migration service of the Ministry of Internal Affairs of the Republic of Kazakhstan.

When registering or deregistering, employees of the migration service draw up statistical registration coupons designed specifically for statistics bodies. These statistics

monthly, in a timely manner, are transferred to regional, city departments of statistics. Regional and city departments of statistics, in turn, check the correctness of filling in the statistical standards, in case of errors or incompleteness of information, they are returned for replenishment. Then statistical standards are transferred to the regional departments of statistics, where the data is encoded according to the Normative and Reference Information, entered into the electronic database, and checked for logical and arithmetic control. After that, the formed databases on population migration are transferred to the Information and Computing Center of the Committee, where logical and arithmetic control is carried out at the republican level, editing, processing of data and the release of tables in accordance with the plan of statistical work for the current year. Then the generated tables are transferred to the Committee on Statistics, where the information is checked, approved and disseminated. Local executive bodies of cities, districts (including districts in cities of regional and republican significance) that carry out state registration of acts of civil status (hereinafter - registering bodies), no later than the 6th day following the reporting month, send second copies to the city (district) statistics departments records of births (together with medical certificates of birth), death (together with medical certificates of death and perinatal death), conclusion and dissolution of marriages (hereinafter referred to as civil status records), selected separately according to the types of civil status records according to the accompanying inventory registration of acts of civil status, which indicates the number of submitted acts and their numbers for each type of acts. Inventories are drawn up in two copies, one of which remains with the registering authorities, the second is sent to the territorial statistical offices. The natural increase and the balance of migration add to the number at the beginning of the previous period.

With significant changes in the boundaries of regions, the population is recalculated since the last national census, taking into account the distribution of demographic events (received by the statistical development after the reporting period) in accordance with the year of their occurrence.

The main sources of information on the population of the country and its regions are data obtained from national censuses. Current estimates of the constant population size by ethnic group at the beginning of the year are calculated on the basis of data obtained from the latest national census, given from the date of the national census to January 1 of the census year, to which the number of births and arrivals by ethnic groups for permanent residence on the territory of the Republic of Kazakhstan or its regions and from which the number of deceased and retired by ethnicity for permanent residence outside the Republic of Kazakhstan or its regions is deducted.
