S.2 Introduction-Relevance

In order to form, on a quarterly basis, the main statistical indicators characterizing the development of the oilseeds industry in the Republic of Kazakhstan, statistical observation was organized according to the statistical form 3-xx "On the presence and movement of oilseeds". This statistical observation relates to the agricultural sector.

Statistical information on the availability and movement of oilseeds in the Republic of Kazakhstan is formed quarterly by types of oilseeds and by types of their use, in the context of regions and by types of activity and is published in express information. The source of information on the availability and movement of oilseeds is the primary statistical data of legal entities and (or) their structural and separate subdivisions, peasant or farms, individual entrepreneurs engaged in the cultivation, processing, trade and storage of oilseeds.

The main indicator is the presence of oilseeds. Oilseeds include sunflower, rapeseed, safflower, soybeans, cotton, cultivated peanuts, curly flax, mustard, sesame, rape, camelina, castor oil plant.

S.4.1 Data description

Express information is generated 4 times a year on a quarterly basis. The data is generated in kind (in tons).

The output information contains data on the presence and movement of oilseeds: by types of crops and by types of use of oilseeds (food, seed and fodder) in the country as a whole, on the presence and movement of oilseeds by type of activity in the country as a whole and in the context regions, cities of republican significance and the capital.

In 2018, the number of respondents was 91.8% of the number of respondents in the catalog.

1. The type of observation is continuous.
2. Data collection toolkit is a statistical form of national statistical observation "On the presence and movement of oilseeds" (code 141103209, index 3-x, quarterly frequency), which is available on the Internet resource Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan www.stat.gov.kz in the section "For respondents" / Statistical forms for 2019 / Quarterly forms.
3. The circle of respondents: legal entities and (or) their structural and separate divisions, peasant or farm enterprises, individual entrepreneurs engaged in the cultivation, processing, trade and storage of oilseeds.
4. The deadline for submitting express information is up to the 15th day (inclusive) after the reporting period.
5. Definitions:
 - 1) oilseeds - plants cultivated for the production of fatty oils;
 - 2) food oilseeds - seeds used for food purposes;
 - 2) fodder oilseeds - seeds intended for feed to animals and poultry;
 - 3) seed - oilseeds used for sowing purposes;

The statistical object is all legal entities and (or) their structural and separate subdivisions, peasant or farm enterprises, individual entrepreneurs engaged in the cultivation, processing, trade and storage of oilseeds.

The observation is carried out by a continuous method.

The collection of data is carried out electronically on-line, and at the request of the respondent, the data can also be presented on paper. In 2018, the number of respondents who reported was 70,040, of which 45.4% of respondents provided data online by means of EDS.

When entering data, respondents are provided with automated arithmetic and logical controls, excluding the possibility of typical input errors. Data processing processes are automated using software systems, which provide for the control of input and output information.

The time spent on filling out the statistical form is on average up to 1 hour.

There is no duplication with other national statistical surveys.
Administrative or other data sources are not used when generating
express statistical information.

S.21.1 Input

Primary statistical data of the statistical form of the national statistical observation "On the presence and movement of oilseeds" (code 141103209, index 3-cx, quarterly periodicity). Food, seed and fodder oilseeds stored by the respondent at the end of the reporting quarter and which the respondent received from the new harvest in the reporting quarter are subject to accounting. In the absence of activity during the reporting period (quarter), the respondent, no later than the end date of the earliest of the deadlines for submitting statistical forms for this reporting period, specified in the Schedule for the submission of primary statistical data by respondents on national statistical observations approved in the manner prescribed by the Law for the corresponding year, shall be submitted to the corresponding state statistics body instead of the corresponding statistical forms Notification of no activity. If a structural unit has been delegated the authority to submit a statistical form by a legal entity, then it submits this report at its location to the statistics authorities.

A separate form is filled in for each oilseed crop.

If the same crop is stored in different territories, a separate form is also filled out for each territory.

S.21.3 Method (method) of collecting primary statistical data

Data collection is carried out on paper or in electronic form by filling out the statistical form 3-cx "On the presence and movement of oilseeds." It is carried out electronically through the use of the "Online Data Collection" information system posted on the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan (<https://cabinet.stat.gov.kz/>).

The reliability of the data is confirmed by primary reports, which are certified on paper by seals and signatures of top managers, and submitted in electronic form - by an electronic digital signature. On the part of the Committee, the quality of data is ensured by the use of arithmetic and logical control methods when checking primary reports. In case of revealing extreme values and sharp deviations, the respondent either confirms the data that raise doubts among the statistics authorities, or makes corrections in accordance with the procedure established by law.
