S.2 Introduction - Relevance

Price statistics is a branch of economic statistics that studies the price behavior of subjects in various sectors of the economy by monitoring the level of prices and their changes through the system of price indices.

Indicators of price statistics are used to assess the state of the market economy, the impact of price changes on the standard of living of the population and business activity.

National statistical observation of producer prices for agricultural products, organized to determine the level of prices for types of agricultural products. The producer price index for agricultural products, formed based on the results of the observation, measures the dynamics of changes in prices for agricultural products.

The producer price index for agricultural products has been formed since 1993.

The producer price index is used in calculating the gross output (hereinafter referred to as GDP) of agriculture:

1) Price indices by types of agricultural products - for deflation, when there are no physical indicators, produced by the statistics of the agricultural sector of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan. 2) Aggregated price indices - when calculating GDP. Price indices at a detailed level - input-output balance at constant prices, for deflation of elements of GDP by the end-use method, produced by national accounts statistics Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan.

The Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan holds meetings of working groups (focus groups), with the participation of potential users and respondents, representatives of interested government agencies, as well as NPP "Atameken", which analyze in detail indicators of national statistical forms for their relevance and avoidance of duplication with indicators of departmental statistical forms and forms of administrative data ". Feedback from users is carried out through the blog of the Minister of National Economy of the Republic of Kazakhstan on the website of the Ministry of National Economy of the Republic of Kazakhstan www.economy.gov.kz.

Producer price indices for agricultural products are calculated by types of agricultural products as a percentage, per month to different periods of comparison, for the period of the reporting year to the corresponding period of the previous year.

Producer prices for agricultural products are formed by types of products for the reporting month and on average for the year.

S.4.2 Classification system

The following basic statistical classifiers are used:

1) KATO - Classifier of administrative-territorial objects;

2) OKED - General classifier of economic activities;

3) SKPSH - Directory of products (services) of agriculture, forestry and fisheries (posted on the website of the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan www.stat.gov.kz in the "Classifiers" section).

S.4.3 Sectoral coverage

The surveyed segment of the economy according to the current General Classifier of Economic Activities (OKED) is represented by the section "Crop production and animal husbandry, hunting and provision of services in these areas" (OKED - 01) in terms of production and sale of crop and livestock products.

Legal entities and (or) their structural and separate subdivisions, peasant or farms carrying out agricultural activities, regardless of the number of employees.

S.4.6 General population (principle of selection of survey units)

The general population for compiling samples of basic objects is the data of the statistical agricultural register and the statistical business register, as well as primary statistical data from a survey of agricultural economic entities that provide information on the value of products sold.

The list of types (subspecies) of products for price observation includes their main types, reflecting the specialization of agricultural production in the Republic of Kazakhstan.

Quality assurance and reliability of price statistics data is supported by generally accepted procedures:

- compliance with the basic principles of primary accounting;

- use of standard statistical classifications of goods, products, services;

- at the stages of collection and processing of primary data, all control schemes (format-logical, arithmetic) have been developed and implemented;

- to confirm the reliability of primary data, the possibility of obtaining additional information from respondents is legally enshrined;

- a comparative analysis of statistical data (in dynamics, intersectoral) is carried out;

- rotation of sample sets of lists of goods, products and basic objects selected for price observation;

- annual review of weighing schemes;

- the use of uniform formulas for calculating price indices at all levels of aggregation.

The accuracy and reliability of the calculated producer price indices for agricultural products is ensured by conducting an optimally selected observation method according to the "Methodology for constructing a producer price index for agricultural, forestry and fishery products." The methodology was developed on the basis of international standards, which laid down the requirements for the selection of basic objects, a list of observed types of agricultural products, statistical observation of prices and procedures for calculating the indicator.

Methodology for constructing a producer price index for agricultural, forestry and fishery products

The collection of prices is carried out in electronic form and on paper at the request of the respondent. Data collection is carried out online, in which automated arithmetic and logical controls are provided for the respondent, excluding the possibility of typical input errors. Information processing processes are automated using local software systems, control of input and output information is provided. There is no duplication with other examinations. No administrative data or other sources are used.

S.21 Processing of statistical data S.21.1 Input data

> The construction of the producer price index for agricultural products involves the use of two data streams: weight components (weighing scheme) and changes in prices for agricultural products. Weighing schemes are formed centrally for each region and the republic as a whole. Their construction is based on the distribution of value data on the volume of agricultural products sold included in the observation.

> The collection of information on changes in producer prices for agricultural products is carried out within the framework of the statistical observation "Report on producer prices for agricultural products and purchased services" (code 261101170, index 1-TsSKh, (monthly frequency)).

S.21.3 Method (method) of collecting primary statistical data

The collection of data is carried out on paper or in electronic form by filling out the statistical form 1-TsSKh "Report on producer prices for agricultural products and purchased services." It is carried out in electronic form through the use of the "Online Data Collection" information system posted on the Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan (www.stat.gov.kz).

S.21.4 Reliability of primary statistical data

Primary statistical data are compiled on the basis of primary accounting documents drawn up in the appropriate manner.

In addition, when entering and processing data, format-logical controls of the minimum and maximum price indices are laid; comparison with the price level of the previous month, control of the price level for types of agricultural products and others. In accordance with Article 17 of the Law of the Republic of Kazakhstan "On State Statistics", the respondent is obliged to submit reliable primary statistical data when conducting statistical observations in accordance with the schedule for submitting primary statistical data by respondents and with statistical methodology.

The imputation is carried out according to the Methodology for constructing the producer price index for agricultural, forestry and fishery products. Replacement of some representative goods for others is carried out at the beginning of the year. To maintain the continuity of the price series during the reporting year, it is allowed to introduce a new representative product to replace the one that was retired.
