 - S. 2 Introduction-Relevance

Mutual trade of the Eurasian Economic Union (hereinafter - the EAEU) is trade between the EAEU member states.

The EAEU member states are Russia, Belarus, Kazakhstan, Armenia and Kyrgyzstan.

The basis for the formation of statistics of mutual trade of the Republic of Kazakhstan with the EAEU countries is a report in the form 1-CU "Report on mutual trade in goods with the member states of the Eurasian Economic Union". Foreign and mutual trade statistics are very important for decision-making, both at the state level and at the level of individual enterprises.

Data on foreign and mutual trade are regularly provided to international organizations: the United Nations (UN database), the International Monetary Fund, the Statistical Committee of the Commonwealth of Independent States, and many other specialized associations and unions.

At the level of the EAEU, data on mutual trade is necessary to monitor the internal market of the EAEU, the economy, during political and trade negotiations.

At the level of the republic, data from foreign trade statistics are needed to compile the balance of payments and the system of national accounts.

The main users of foreign trade statistics in the public sector are the Administration of the President of the Republic of Kazakhstan, the Office of the Prime Minister of the Republic of Kazakhstan, the National Bank of the Republic of Kazakhstan, the Ministry of National Economy of the Republic of Kazakhstan, the Ministry of Finance of the Republic of Kazakhstan, the Ministry of Foreign Affairs of the Republic of Kazakhstan and other departments.

Businesses use foreign trade statistics for market research.

The number of users of foreign trade statistics is increasing every year.

The Bureau of national statistics holds meetings of working groups (focus groups), with the participation of potential users and respondents, representatives of interested government agencies, as well as NPP "Atameken", at which the indicators of national statistical forms are analyzed in detail for their relevance and the elimination of duplication with indicators departmental statistical forms and forms of administrative data.

Features of the organization of collection and processing of data from statistics of mutual trade, which may be objective reasons for data discrepancies:

- incomplete coverage of data on statistics of mutual trade due to the presence in the EAEU countries of foreign trade participants who have not submitted a statistical form;
- the use of various EAEU nomenclature of goods subject to foreign trade codes by foreign trade participants;
- the presence of a time lag between the date of shipment of goods for export in the country of departure and the date of registration of import in the receiving country (carry-over deliveries).

S.17.1.1 Asymmetry on Mirror Stream Statistics - Coefficient / CC1

Based on the results of comparisons and updating of the data for 2017, the discrepancy in the data was reduced from 36.6% for the export of Kazakhstan to Armenia with the data of the import of Armenia from Kazakhstan to 2.0%, for the import of Kazakhstan from Armenia with the data of the export of Armenia to Kazakhstan the discrepancy was reduced from 6.1% to 2.2%.

The methodology in the field of international merchandise trade statistics was developed within the framework of the KAZSTAT Project (Project on Strengthening the National Statistical System) jointly with the World Bank, in accordance with the recommendations of the Federal Statistical Office of the Federal Republic of Germany and the experience of the European Union countries.

The methodology in the field of international merchandise trade statistics has been agreed with all structural units of the Bureau of national statistics.

Data collection is carried out electronically and on paper at the request of the respondent.

Data collection is carried out online, in which automated arithmetic and logical controls are provided for the respondent, excluding the possibility of typical input errors.

Information processing processes are automated using local software systems, control of input and output information is provided.

S.21.3 Method (method) of collecting primary statistical data

According to foreign trade statistics, data on declarations for goods are submitted in electronic form.

According to the statistics of mutual trade with the EAEU countries, the submission of the statistical form is carried out on paper or in electronic form.

Filling in the statistical form in electronic form is carried out through the information system "Data collection in on-line mode" posted on the Internet resource Bureau of national statistics of the Agency for strategic planning and reforms of the Republic of Kazakhstan (www.stat.gov.kz).

S.21.4 Reliability of primary statistical data

At the level of inputting primary data in electronic format, various formatlogical controls are included in the software for processing primary statistical information.

Data analysis is carried out in dynamics, at average prices, by an additional unit of measurement, etc.

In accordance with the Unified Methodology for Maintaining Customs Statistics of Foreign Trade and Statistics of Mutual Trade of the Member States of the Customs Union, approved by the Decision of the CCC of January 28, 2011 No. 525, a mirror comparison of data on statistics of mutual trade with data of the authorized bodies of the EAEU member states is carried out.

In accordance with the "Methodology in the field of maintaining statistics of international trade in goods" approved by order of the Chairman of the Bureau of national statistics dated December 14, 2015 No. 204, in order to ensure the completeness of the official statistical information of the EAEU member states, statistical adjustments of unaccounted volumes of mutual trade in goods are carried out on the basis of information, submitted by the tax authorities.

S.21.6 Adjustment

Data correction is carried out at the detailed level of 10-digit EAEU nomenclature of goods subject to foreign trade codes and at the enterprise level in the context of partner countries.

After the enterprise makes the appropriate adjustments, the Bureau of national statistics updates the data of the statistics of mutual trade.

Correction of data is carried out on a monthly basis when errors of respondents are found in primary reports.

In addition, in accordance with the Decision of the EEC Board No. 224 dated December 2, 2014 "On the provision of official statistical information to the EEC", an annual update of data on statistics of mutual trade with the EAEU countries is envisaged after annual meetings of authorized bodies and identifying the reasons for discrepancies in the data, after ensuring full coverage of respondents based on the use of administrative sources, after making adjustments based on data from tax authorities.

The procedure for monthly and annual data updating is stipulated by the Statistical Work Plan.
