

Brief methodological explanations

Gross domestic product (GDP) is one of the most important indicators of the System of National Accounts, characterizing the final result of the production activities of resident economic units. GDP can be calculated by three methods that correspond to the various stages of reproduction — the production method, the income method, and the end-use method.

Gross domestic product at the production stage is obtained by summing the gross value added by industry. Gross domestic product is calculated at market prices, that is, it includes net taxes on products. The term «net» means that taxes are shown net of related subsidies.

Gross value added is calculated at the industry level as the difference between the output of goods and services and intermediate consumption. The term «gross» indicates that the indicator includes the value of fixed capital consumed in the production process.

Gross Regional Product (GRP) - the final result of the production activities of resident producer units of a particular region over a specified period of time and calculated at market prices.

Index of physical volume (IPV) is a relative indicator characterizing the change in production volumes in the compared periods. It is calculated by dividing the cost of a certain indicator in the current period, estimated at the prices of the base period, by its value in the base period.

Deflator - an indicator that characterizes the average change in prices in the economy over a certain period.

- According to the International Monetary Fund rating, Kazakhstan at the end of 2020 ranks 40th in terms of the nominal value of GDP, calculated at purchasing power parity

- High GRP growth rates for 2020 are observed in the Turkistan (4.9%), Kostanai (3,0%) and Akmola regions (2.7%)


