An explanation for completing the census form for the national population census of the Republic of Kazakhstan in 2021 "List of dwellings, residential buildings (residential buildings) and non-residential premises" (index 1-SZh, periodicity: one-time) is given in the annex to the census form for the national population census of the Republic of Kazakhstan in 2021 "List of dwellings, residential buildings (residential buildings) and non-residential premises" (index 1-SJ, periodicity: one-time).

Explanation of filling out the census form for the national population census of the Republic of Kazakhstan in 2021 "List of dwellings, residential buildings (residential buildings) and non-residential premises" (index 1-SZh, frequency: one-time)

1. In the census form for the national census of the Republic of Kazakhstan in 2021 "List of dwellings, residential buildings (residential buildings) and non-residential premises" (index 1-CЖ, frequency: one-time) (hereinafter - the census form) all dwellings, residential houses (residential buildings) and non-residential premises where the population lives or possibly lives.

2. Each dwelling, residential building (residential building) and non-residential premises shall be recorded in the census form separately and sequentially, in the order of their location.

3. Column 1 of section 1 of the questionnaire shall indicate:

in line 1.1, the code and name of the administrative-territorial unit;

in line 1.2 street type according to the reference book of the integrated information system "e-Statistics" (hereinafter - IIS "e-Statistics");

in line 1.3, the address of a dwelling, residential building (residential building) and non-residential premises recorded first along this avenue, street, square, lane, passage, opposite other dwellings, residential buildings (residential buildings) and non-residential premises, the symbol - "-u- ";

in line 1.4 the type of dwelling, residential building (residential building) and non-residential premises according to the reference book in the IIS "e-Statistics";

in line 1.5 the status of the dwelling, residential building (residential building) and non-residential premises according to the reference book of the status of objects in the IIS "e-Statistics";

in line 1.6, the number of the dwelling, residential building (residential building) and non-residential premises. For a dwelling, a residential building (residential building) and non-residential premises, the numbers of which are indicated by an additional digit or letter numbering, both basic and additional designations are indicated (for example, 8a, 5/1).

If a dwelling, residential building (residential building) and non-residential premises consist of several large multi-apartment buildings (blocks), designated by additional numbering (for example, building A, building B or building 1, building 2), then each such building (block) is written in census sheet on a separate line indicating the general number and number of the body (block) (for example, 5 body (block) A, body (block) B, 1/18 body (block) 2).

The number of dwellings, residential buildings (residential buildings) and non-residential premises does not include outbuildings in which the population does not live due to their design features (for example, garages), in case of residence, they are entered into the census form.

All existing new dwellings, residential buildings (residential buildings) and non-residential premises are marked on the map, indicating the number of the population living in them;

in line 1.7 if the copyright holder is a legal entity, then its name, if an individual (including an individual entrepreneur) his last name, first name and patronymic (if any). If there are several copyright holders, each of them is indicated.

For the plots on which the construction of dwellings, residential buildings (residential buildings) and non-residential premises (if no one lives in them), in line 1.7 of section 1 of the census form, the data of the copyright holder who owns the dwelling under construction, residential building (residential building) and non-residential premises and in line 1.10 it is noted “dwelling, residential building (residential building) and non-residential premises under construction”;

in line 1.8, the number of permanent residents: in social service centers, orphanages, rest homes, boarding schools for

orphans and children left without parental care, boarding houses, sanatoriums, children's homes and other institutions, organizations where the permanent population lives;

in line 1.9, the number of beds in hospitals, sanatoriums, hotels, rest homes and others where the temporary population lives and (or) resides;

in line 1.10 any changes and comments on this dwelling, residential building (residential building) and non-residential premises.

4. Section 2 of the census form is completed for all dwellings and non-residential premises in which the population lives.

Section 2 of the questionnaire indicates:

in column 1 the number of an apartment, a room in a dormitory, an individual residential building;

if the number is indicated by an additional digit or alphabetic numbering, both basic and additional designations are recorded (for example, 8a, 5/1);

in column 2 the type of apartment, room, individual residential building according to the IIS “e-Statistics” reference book;

in column 3 the number of permanent residents.

At the same time, in column 3 of section 2 of the census form, data are recorded on the permanently resident population (excluding temporarily residing), including temporarily (less than 12 months) absent. Persons who are absent for more than 12 months, as well as those who left for military service or study (with a training period of 12 months or more), regardless of the period of their departure, are not included in column 3;

in column 4 the data of the rightholder, if the dwelling and non-residential premises in which the population lives belongs to several rightholders, then each of them is indicated;

in column 5 any changes and comments on this dwelling and non-residential premises in which the population lives.

5. Upon completion of the tour of all dwellings, residential buildings (residential buildings) and non-residential premises of the site and entering the necessary information into the census sheet, the interviewer compares their number recorded in the census form with the information indicated on the map of his site.

In the event that, during the round-trip, the interviewer finds a dwelling, a residential building (residential building) and non-residential premises that are not on the site map, the interviewer enters it into the questionnaire and marks it on electronic and (or) paper.
