Explanation on filling out the census form for the national census of the Republic of Kazakhstan in 2021 "Housing conditions" (index 2-ZHs, Frequency: one-time)

- 1. When filling out the census form for the national census of the Republic of Kazakhstan in 2021 "Housing conditions" (index 2-ZHs, Frequency: one-time) (hereinafter census sheet), appropriate marks are made in the listed answer options, and, if necessary, are entered numbers and / or text.
- 2. The Census sheet is completed by one of the respondents from each household. Questions 1, 2, 3, 4, 5, 6, 7 of the census questionnaire refer to the dwelling in which the households live. Questions 7.1 and 8 of the census questionnaire apply to each household living in this dwelling.
 - 3. Question 1 of the questionnaire uses the following explanations:
- 1) if the household lives in an individual house, a cottage-type residential building, regardless of the form of ownership, the "single-family (individual house)" is marked;
- 2) if the household lives in an apartment building, one of the answer options is marked: "two-apartment building" or "three or more apartment buildings";
- 3) if in a specially built or converted for the residence of persons working under an employment contract, students (cadets, graduate students) and students during their studies, as well as other persons who have an employment contract with the owner or owner of the hostel, the "Hostel" is marked.

If the answer is "Other (for example, yurt, gatehouse, wagon, container)", the census sheet is not filled out further.

- 4. In question 2 of the questionnaire, the answer is not completed if the respondent who is part of the household (hereinafter referred to as the respondent) does not have information about the year of construction of residential buildings (residential buildings).
- 5. In question 4 of the questionnaire, if the walls are constructed of several materials, the material that prevails in the building should be indicated. If the respondent does not have information about the material of the outer walls, the answer to the question is not filled in.
 - 6. In question 5 of the census form, the dwelling is considered equipped: electricity, if there is electrical wiring in the house;

an electric stove (floor), if there is an electric stove (floor), or a house with a detached kitchen (a capital building specially designed for the kitchen), in which an electric stove (floor) is installed;

mains gas (natural), if there is a gas stove equipped with mains natural gas;

liquefied gas (in cylinders or in gasholders - tanks for storing gaseous substances), if there is a floor gas stove equipped with liquefied gas, a house with a detached kitchen in which a gas stove equipped with liquefied gas is installed is also considered gasified;

central heating, if there is heating from your own home boiler room, district or district boiler room, combined heat and power plant, as well as the installation of an automatic gas water heater;

autonomous heating (heating from individual installations, boilers): stove heating, if there is heating from heating installations or equipment using gas, solid or liquid fuels located inside a occupied traditional dwelling or as a backup option for exceptional cases from owners of large private houses or cottages, and in temporary houses;

renewable energy sources - energy sources that are continuously renewable due to naturally occurring natural processes, including the following types: solar radiation energy, wind energy, hydrodynamic water energy; geothermal energy: heat of soil, groundwater, rivers, reservoirs, as well as anthropogenic sources of primary energy resources: biomass, biogas and other fuels from organic waste used for the production of electrical and (or) thermal energy;

plumbing in the house (building or apartment), if there is a distribution network inside the house, into which water is supplied centrally from a water supply system or an artesian well;

water supply outside the house (building or apartment), if outside the house (a detached kitchen or identical rooms outside the house) there is a distribution network into which water is supplied centrally from a water supply system or an artesian well;

a well, a column or an identical source of water supply, if there is a well or a water tap (column) or an identical source of water supply in the yard of the house;

delivery of drinking water, if the house does not have the above water supply sources, and the delivery of drinking water is carried out by transport from other regions, distant sources or from identical water supply sources;

a bathroom (toilet with a flush), if there is a toilet (a toilet with a flush) in the dwelling and a sewerage device for the drainage of household and fecal water into the street sewer network or absorbing wells;

central sewerage, if inside the house there is a sewerage device for the drainage of household and fecal water into the street sewer network or absorption wells. A dwelling is not equipped with sewerage, in which there is no water supply, as well as in the presence of a dry closet;

other sewerage system, liquid household waste from residential buildings (residential buildings) that are not connected to the drainage system of the settlement should be discharged into waterproof cesspools with subsequent removal by special vehicles and discharge at drainage stations, the places of installation of which are determined by the territorial divisions of the authorized body in the region sanitary and epidemiological well-being of the population, the territorial body of the authorized state body in the field of environmental protection and the organization for

water supply and (or) wastewater disposal;

a stationary bath or shower, if a bath or shower is installed, both in a separate bathroom and in another room adapted for this purpose, regardless of the way hot water is supplied, and it is not considered an equipped bath or shower dwelling in which a bath (shower) is installed, and there is no sewage;

central hot water supply, if there is a special water supply system that supplies hot water centrally for the domestic needs of residents;

hot water supply from individual water heaters, if there is a special water supply system that supplies hot water from a gas (wood) water heater, apartment water heaters, including small-sized heating boilers;

collection and removal of garbage, if stationary collection and removal of garbage is carried out from the dwelling;

communication services:

fixed telephone communication, if a fixed telephone set is installed, including a radiotelephone, and there is an agreement with communication operators;

fixed access to the Internet, if a modem is installed, including wi-fi, and there is an agreement with telecom operators;

mobile Internet, if the home has a mobile signal and web pages are opened through browsers (can be checked using a cell phone);

television:

satellite television, if the respondent uses a television, a satellite outdoor antenna (in the form of a "dish" installed outside the dwelling on the wall, roof or personal plot) to watch television channels, a converter and a satellite television settop box;

cable television, if the respondent uses a television connected to the services of a cable operator to watch television channels and has entered into an agreement with certain cable operators;

on-air television, if TV, a set-top box and an ordinary decimeter indoor or outdoor antenna are used to watch TV channels, while up to 30 TV channels are available for the cities of Nur-Sultan, Almaty, Shymkent and regional centers, and for settlements below the regional center up to 15 TV channels ...

7. Questions 6 and 6.1 of the census form indicate the dimensions of the total and living area of the dwelling in whole numbers, without decimal places and commas.

The total area does not include the area:

- 1) staircases, elevator halls, vestibules, corridors (except for apartments), lobbies;
 - 2) occupied by protruding structural elements and heating furnaces;
 - 3) detached summer kitchens, baths, sheds, gazebos.

In questions 6 and 6.1 of the questionnaire, the answers are not completed if the respondent does not have data on the size of the total and living space.

8. Question 7 of the questionnaire indicates how many living rooms there are in the living quarters (except for the kitchen, bathroom, toilet, hallway, storerooms).

- 9. In question 7.1 of the questionnaire, the number of living rooms occupied by the household is indicated in numbers. If the household does not occupy the entire room, but only a part of it, "part of the room" is marked.
 - 10. In question 8 of the questionnaire:

if the dwelling is owned by one respondent who is a member of the household, mark "household respondent";

if the dwelling is owned by several or all of the respondents who are part of this household, it is marked "respondents who are part of the household";

if the household lives in a dwelling owned by relatives, friends, acquaintances, it is noted to an individual

"With payment" or "without payment";

if the household lives in a dwelling belonging to a legal entity on the basis of private property rights, it is noted to the legal entity "with payment" or "without payment";

if the household lives in a dwelling that is owned by the state housing stock, the "State property" is marked.
