S.2 Introduction - Relevance

This statistical observation relates to the social security industry. The statistical form is compiled on the basis of the data from the primary accounting documentation. Recipients of special social services - disabled children with neuropsychiatric pathologies, disabled children with musculoskeletal disorders, disabled people over eighteen years of age with neuropsychiatric diseases, disabled persons of the first and second groups, persons who are not capable of self-service due to old age, persons homeless, victims of domestic violence and human trafficking, persons released from prison and (or) registered with the probation service. The data is filled in in accordance with the Standard for the provision of special social services in the field of social protection of the population, approved by order of the Minister of Health and Social Development of the Republic of Kazakhstan dated March 26, 2015 No. 165, registered in the Register of State Registration of Normative Legal Acts under No. 11038.

S.4 Presentation of statistical information

S.4.1 Data description

Organizations for the provision of special social services in accordance with the Standard for the provision of special social services in the field of social protection of the population include the following types of organizations: stationary and semi-stationary type, temporary stay, with several conditions for the provision of special social services. In statistical reporting, data on organizations providing special social services and the contingent of those living in these organizations are given by type of locality, type of ownership, age, disability groups, broken down by persons with disabilities with musculoskeletal disorders and mental disorders of behavior.

S. 4.3 Sectoral coverage

The circle of respondents is represented by legal entities and (or) their structural and separate divisions, whose activities are aimed at providing special social services in the field of social protection of the population (codes 87, 88 of the General Classifier of Economic Activities), regardless of ownership and departmental affiliation.

S.4.4 Statistical concepts and definitions

1. Type of observation - continuous observation.
2. To generate data on social security, the number and structure of organizations for the provision of special social services by type of ownership, the contingent of residents are used: retirees by age, single homeless people, participants and invalids of the Great Patriotic War, persons without a fixed abode, persons released from places of deprivation freedoms, victims of domestic violence, victims of human trafficking and the number of people living on a paid basis, disaggregated by disability group, age and other indicators.

Lonely rootless persons - disabled and elderly people who do not have able-bodied adult children, the spouse is obliged in accordance with the Code of the Republic of Kazakhstan of December 26, 2011 "On marriage (matrimony) and the family" to support their disabled parents who need help, spouse) and take care of them, or having able-bodied adult children, spouse (s) who, for objective reasons, cannot provide them with constant help and care (have disabilities of the first, second groups, oncological, mental diseases, are in prison, are on registered in a narcological dispensary or left for permanent residence outside the country, additionally for the spouse - being in old age).

A victim of domestic violence is an individual in relation to whom there is reason to believe that moral, physical and (or) property damage has been inflicted on him directly by an offense related to domestic violence, determined on the basis of the Criteria for assessing the presence of cruel treatment leading to social maladjustment and social deprivation approved by the joint order of the Minister of Internal Affairs of the Republic of Kazakhstan dated September 22, 2014 No. 630, the Minister of Education and Science of the Republic of Kazakhstan dated September 26, 2014 No. 399 and the Minister of Health and Social Development of the Republic of Kazakhstan dated November 19, 2014 No. 240, registered in the Register of State registration of normative legal acts numbered 10013.

Victim of trafficking in persons - an individual in respect of whom there is reason to believe that he or she has directly suffered from an offense related to trafficking in persons, regardless of the fact of initiation of criminal proceedings for the committed actions;
